Child care payments

In order to provide stable funding and encourage more childcare providers to participate in the grant program, supplier's payment practices should reflect the generally accepted practices of suppliers who take care of children who do not receive subsidies. In many cases, subsidies payments are unpredictable and are based on the participation of individual children, which means that suppliers cannot rely on stable assistance. When suppliers do not have stable funding sources, they cannot undertake to hire highly qualified personnel and are often unable to provide personal training and professional development opportunities. All these practices are contrary to CCDF's purposes to offer high quality and coordinated initial education services and coordinated to maximize parental options and increase the number and percentage of low-income children in childcare settings to high quality. Payment practices are generally accepted are the practices that align with the private pay market for children in order to encourage suppliers to accept children who receive subsidies and allow families to preserve childcare services. The final rule of the CCDF requires the following practices (unless the lead agency does not provide proof that they are not generally accepted in the State or in the service area):

The act provides that lead agencies, as far as possible, implement enrollment policies and suitability that support the fixed costs of providing assistance services to childhood, eliminating payment rates by a suitable child , due to vacations or unexpected circumstances as the disease. Furthermore, paying for days when children are occasionally helps promote the continuity of care, allowing suppliers to keep slots for children without incurring a financial loss. If the lead agency elects this option in its payment practices, the CCDF plan must face the following: provide rationality rationality Allow suppliers to charge for families the additional amounts above the requested payment, even demonstrating how politics promotes convenience and access for families. Provide data (including data on the size and frequency of these amounts) on the extent that CCDF suppliers charge additional amounts to families. Finally timely payments, CCDBG ACT requires timely payments. As a way to ensure that payment practices are fair for suppliers and support high quality services, states should examine their administrative mechanisms. Through the Federal Coronavirus Response and Relief Supplemental Appropriations Act (CRRSA) of 2021, accredited to the State's Child Care and Development Block Grant Award, an additional \$60 million funds are directed to support early service and education providers. Additional funds will allow DCF to conduct another cycle of payments supporting suppliers of early assistance and education. The payment program COVID-19 Response and Relief is designed to compensate for the continued impact of pandemic on costs associated with providing early assistance and training. The last round of funding will be distributed through two programs aimed at the current challenges that early care providers and education are facing. This will be the third payment program managed by DCF in response to the COVID-19 pandemic. To date, almost \$191 million was paid to child care providers through Child Care Counts payment programs.
